You are not given greater rights than represented parties and must bear the consequences of your mistakes (*Williams v. First Merit Bank, N.A., 9th Dist. No. 24011, 2008-Ohio-5038*).

Pleadings MUST be reduced to writing and presented to the Court in person or by mail. You are responsible for providing a copy of the pleadings to all parties of record.
