## RIGHT TO COUNSEL:

Any party is entitled to be represented by an attorney throughout these proceedings. the date set for hearing. Upon receipt of the form, the Court will review the information and determine whether you qualify for court-appointed services. A hearing may be held if your application is incomplete or unclear.

The State Public Defender requires that you pay an application fee of \$25.00. This fee may be added as costs at the conclusion of this case if you do not pay at the time of presenting your affidavit of indigency. Please read the affidavit carefully because it contains important information about the potential recoupment process.

You have the right to represent yourself as a pro se litigant. Please take notice that you are presumed to have knowledge of the law and correct legal procedures. Therefore, you remain subject to the same rules and procedures to which represented litigants are bound. You are not given greater rights than represented parties and must bear the consequences of your mistakes (Williams v. First Merit Bank, N.A., 9th Dist. No. 24011, 2008-Ohio-5038).

Pleadings MUST be reduced to writing and presented to the Court in person or by mail. You are responsible for providing a copy of the pleadings to all parties of record.
